

**Remove Regular Town Board Meeting  
April 24, 2018 6:15 PM**

Supervisor Votra opened the meeting with the Pledge of Allegiance at 6:15 PM.

**Roll Call:** Supervisor Votra, Councilwoman Tremper, Councilman Cook, Councilman Sweeney, Councilman Demo, Assessor and Code Enforcement Officer McGill, Highway Superintendent Hart, Deputy Town Clerk Remington.

*A motion* was made by Councilman Demo and seconded by Councilwoman Tremper to approve the minutes of the Regular meeting on March 27, 2018, as submitted by the Town Clerk.

**Code Enforcement Officer Report:**

**Business:**

- a. *A motion* was made by Councilwoman Tremper and seconded by Councilman Sweeney to adopt the Cold War Exemption Local Law 02-2018 as follows:

**TOWN OF PARISHVILLE, NEW YORK  
LOCAL LAW NO. 02 OF THE YEAR 2018**

A local law to establish the real property tax exemption for Cold War Veterans in the Town of Parishville, New York pursuant to the provisions of New York State Real Property Tax Law Section 458-b.

**BE IT ENACTED** by the Town Board of the Town of Parishville, New York as follows:

Section 1

Pursuant to New York State Real Property Tax Law Section 458-b, a Cold War Veteran who is a qualified owner of qualified residential real property within the Township shall be entitled to fifteen percent (15%) exemption from Town real property taxation pertaining to such real property to the extent of fifteen percent (15%) of the assessed value of such property provided, however, that such exemption shall not exceed Twelve Thousand and 00/100 Dollars (\$12,000.00) multiplied by the latest State Equalization Rate applicable to the Township whichever is less. For so long as they remain qualifying owners of qualified residential real property, such qualified owners shall be entitled to such

exemption without regard to the ten (10) year limitation set forth in Real Property Tax Law Section 458-b (2)(c)(iii).

Section 2

Any and all exemptions granted pursuant to the terms and provisions of this local law must conform to the provisions of New York State law set forth in Real Property Tax Law Section 458-b.

Section 3

The exemption provided for in this local law shall apply to assessment rolls prepared pursuant to the first taxable status date occurring on or after the effective date of this local law.

Section 4

This local law shall take effect upon the date of its filing with the New York State Department of State.

Section 5

This local law supersedes Local Law No. 1 for the year 2009 of the Town of Parishville, New York.

- b. *A motion* was made by Councilman Cook and seconded by Councilwoman Tremper to approve the revisions to the agreement to spend Highway Funds.

**Highway Superintendent's Report:**

Highway Superintendent Hart asked the Town Board's approval to change paving to Charles Street, Clark Street and Pleasant Street instead of Capell Street.

*A motion* was made by Council Demo and seconded by Councilwoman Tremper approve the request to pave Charles Street, Clark Street and Pleasant Street.

*All in favor.*

Superintendent Hart reported the highway men are busy cleaning trucks, painting, patching roads and grooming intersections. Superintendent Hart said Pat Curran will come and grind the brush at the brush pit.

Councilman Sweeney has talked to Superintendent Hart about replacing some of the sidewalks, he will try to work it in.

Superintendent Hart will pave Clark Street, Pleasant Street and Charles Street this year for a total of 2.08 miles.

Superintendent Hart has ordered a new truck from Tracy Road Equipment and a Tenco plow for a total of \$194, 00.00. This will replace the truck that is used on State Highway 72. Supervisor Votra will get account information together for next meeting.

*A motion* was made by Councilwoman Tremper and seconded by Councilman Demo to accept the Highway Report as given.
