Code Enforcement Officer Report:

The monthly report submitted by Code Enforcement Officer Burl was read aloud. No questions or comments were offered.

Recreation Report:

Maintenance Supervisor Jacot reported a very, very busy month with the opening of the park and getting staff hired. There is still a need for more lifeguards. The counselors have all been hired and the New York State Department of Health will be doing a walk-through inspection tomorrow. The Summer Recreation program will run from July 7th to August 12th this year. A tree was taken down in the West Parishville Cemetery by Town employee Todd Daby and the fields are all set for soccer.

A motion was made by Councilman Sweeney and seconded by Councilwoman Tremper to accept the Recreation report as submitted by Maintenance Supervisor Jacot. All in favor.

PARC Report

Councilwoman Tremper reported that soccer has started. Co-ed travel soccer for U12 and U18 is still in need of players. The U6, U8 and U10 will start after July 4th. A donation was received from Attorney Roger Linden for \$650 which was matched by PARC to purchase 60 new soccer balls. Brittany Bisnett donated her time to paint a sign/mural in the Rec Center with the PARC logo. The paint was purchased by PARC and it looks great.

A motion was made by Councilman Cook and seconded by Councilman Sweeney to approve the PARC report as given by Councilwoman Tremper. *All in favor.*

Highway Report:

Highway Superintendent Hart reported the paving has been finished and 4.64 miles were done. Mowing has been done and the department has been busy fixing washouts, replacing culverts and putting down mulch.
