# Regular Town Board Meeting November 28,2017

Supervisor Votra opened the meeting with the Pledge of Allegiance at 10:00 AM.

## **Code Enforcement Officer Report:**

Superintendent of Public Works Woods reported quite a few water shut offs with some residents leaving for a warmer climate for the winter months. There have been no problems reported and the water samples have been completed for the year.

A motion was made by Councilwoman Tremper and seconded by Councilman Sweeney to accept the Water District report as given by Superintendent of Public Works Woods. All in favor.

## **Recreation Report:**

Superintendent of Public Works Woods reported maintenance of the equipment has been completed and the garage and shed have been reorganized. The Zamboni has been worked on and the liner for the ice rink will be installed soon.

## **Recreation Committee Report:**

Councilwoman Tremper reported the Biddy Basketball registration has been completed and the school will be used on Saturday mornings for this program. The Learn to Skate program is being organized and PARC is looking forward to next year.

*A motion* was made by Councilman Cook and seconded by Councilwoman Robinson to adopt the following resolution:

#### **TOWN OF PARISHVILLE**

#### RESOLUTION 05-2017 OPPOSING WIND FARM DEVELOPMENT IN PROXIMITY TO FORT DRUM

**WHEREAS,** protecting the North Country's airspace is vital to Fort Drum's future as the Army is continually evaluating the effectiveness of its training installations; and

**WHEREAS,** wind farm development can be an important initiative to pursue as it offers an alternative green source of energy that is pollution free and generated at the source, and while

we recognize the benefits of wind farm development, we simply do not want the strategic location of Fort Drum and their mission readiness capability to be diminished; and

**WHEREAS,** the major economic engine of the North Country and largest single site employer, the economic vitality of the region and thousands of jobs depend on its continued relevance to the Army mission; and

**WHEREAS,** protecting and enhancing Fort Drum, home to the 10<sup>th</sup> Mountain Division, is of utmost priority to the Town of Parishville;

**NOW THEREFORE BE IT RESOLVED** that the Town Board of the Town of Parishville opposes the industrial wind projects being evaluated by New York State's Article 10 Siting Board and the Public Service Commission in the immediate proximity to Fort Drum to ensure the national security and continued readiness for future training missions.

Dr. Collins stated that the bus garage size does need to be addressed at some point since the new buses are quite a bit larger than in the past.
